Definitions:

Organizer: Bijzondere Roadtrips BV

Aurora Roadtrip: An organized road trip through Scandinavia based on self-driving cars, with competitive and/or game elements.

Team: A group of 2 participants taking part in the Aurora Roadtrip.

Entry Fee: The amount paid by a team, based on double rooms, to participate in the Aurora Roadtrip. This amount is exempt from VAT.

Briefing: A meeting organized by the organization to provide important information regarding rules, changes, route, and other matters.

Tracking System: A system installed in the participating vehicles, allowing the organization to monitor the vehicle's position and speed.

Article 1: Registration for Participation

- Registration for participation in the Aurora Roadtrip 2025 takes place via the registration form available at [www.auroraroadtrip.nl/inschrijven].
- Registration through the online form is final and obligates payment of 30% of the entry fee.
- Upon acceptance, the team will receive a confirmation email. The organization reserves the right to refuse registrations without providing reasons, confirmed in writing.

Article 2: Entry Fee and Payment Schedule

- The entry fee for the Aurora Roadtrip 2025 is €5,250 per team.
- After registration, an invoice for 30% of the entry fee will be sent.
- A second invoice for 50% of the entry fee will be sent on 01-09-2024.
- The final invoice for the remaining 20% will be sent on 01-11-2024.
- Payment must be made within 7 days of the invoice date.

Article 3: Single Room Surcharge

A surcharge of €495 per person applies for single rooms.

Article 4: Cancellation by Teams

• In case of cancellation, the already paid entry fee (first invoice) is non-refundable.

- By mutual agreement with the organization, the registration can be transferred to another team until 1st September 2024. If desired, the organization can assist in finding a replacement team. Transfer fees may apply, depending on the work already completed.
- Participants can opt for cancellation insurance to protect against this risk.
- In case of cancellation, the following fees apply to the remaining entry fee:
 - o Before 01-09-2024: 30% of the remaining entry fee
 - o Before 01-11-2024: 50% of the remaining entry fee
 - o After 01-11-2024: The full entry fee

Article 5: Cancellation by the Organization

- If the Aurora Roadtrip is canceled, shortened, or interrupted due to force majeure or other unforeseen circumstances beyond the organization's control, the following rules apply:
- Cancellation before 01-11-2024: 100% refund of the entry fee
- Cancellation between 01-11-2024 and 15-12-2024: 75% refund of the entry fee
- Cancellation between 15-12-2024 and 08-01-2025: 50% refund of the entry fee
- Cancellation on the day of departure, or trip shortening or interruption: no refund
- Uncontrollable circumstances include, but are not limited to, negative travel advisories (code orange or red) issued by the involved countries.

Article 6: Withdrawal

• If a team withdraws or decides to stop during the Aurora Roadtrip, for any reason, the entry fee will not be refunded.

Article 7: Age, Driver's License, Passport/ID, and Insurance

- Participants must be at least 21 years old with a minimum of 2 years of driving experience.
- Both participants must hold a valid international driver's license and passport, valid for at least one week after the end of the Aurora Roadtrip.
- The participating vehicle must be insured, and the green insurance card must be carried during the trip.
- Teams are required to adhere strictly to local traffic regulations. Repeated violations may lead to disqualification (see Article 23).

Article 8: Traffic Rules and Safety

• Teams must always respect local traffic regulations. The organization reserves the right to disqualify teams for serious violations.

Article 9: Navigation and Route

- The route largely runs through Scandinavia, with entry via Germany.
- Before departure, an information meeting will be organized, where the navigation system and competitive elements will be explained.

Article 10: Information Meeting

• Before the Aurora Roadtrip, an information meeting will be held in autumn 2024 to clarify important aspects of the trip.

Article 11: Vehicle

• All participating vehicles must be legally roadworthy.

Article 12: Included and Excluded Costs

- Included costs:
 - Hotel accommodations
 - Breakfast and dinner (except during a 24-hour leg)
 - Activities organized by the organization
 - o Ferries with a crossing time of more than 2 hours
- Excluded costs:
 - Personal expenses
 - o Lunch
 - o Dinners on own initiative
 - Entry fees for non-organized activities
 - Short ferry services
 - o Toll fees
 - o Fuel

Article 13: Emergencies and Assistance

- Teams are required to assist other teams in need.
- In case of emergency, teams must call the organization's emergency number.

Article 14: Tracking System

- Each team will receive a tracking system on loan.
- Failure to return the tracking system on time will incur a fine of €500, excluding VAT.
- It is prohibited to disconnect or tamper with the tracking system.

Article 15: Mobile Phone

- Each team must carry a working mobile phone that is always switched on.
- The organization will provide important information during the road trip via this phone.

Article 16: Liability and Waiver of Responsibility

Participants take part in the Aurora Roadtrip at their own risk. Prior to the event, all
participants will sign a waiver releasing the organization, sponsors, and volunteers
from any liability.

Article 17: Media and Image Rights

 Interviews and images related to the road trip may be used by the organization for media purposes without further permission, in compliance with applicable privacy laws (GDPR).

Article 18: Use of Name and Logo

• Without the organization's consent, it is prohibited to use the name or logo of the Aurora Roadtrip, except for advertising on participating vehicles and clothing.

Article 19: Data and Communication

 Participants agree to receive information about the Aurora Roadtrip via electronic communications.

Article 20: Advertising and Sponsorship

- Participants must affix required sponsor stickers to their vehicle.
- It is permitted to seek sponsors on your own, as long as they do not conflict with the organization's sponsors.

Article 21: Briefings

• Briefings will be held both digitally and in person before the event. Participation in these briefings is mandatory for all teams.

Article 22: Environment and Nature

• Teams are expected to respect the environment and nature. Ignoring these rules may result in penalties, including disqualification.

Article 23: Disqualification

• Teams may be disqualified by the organization for rule violations, dangerous driving, disregard for traffic laws, or other misconduct.

Article 24: Self-sufficiency and Facilities

- Participants are expected to provide for their own needs.
- Hotels and accommodations are arranged by the organization.

Article 25: Risks

• The Aurora Roadtrip involves risks. Participants are responsible for their own safety and that of their vehicle. Travel insurance and accident insurance are highly recommended.

Article 26: Rights and Awards

• No rights regarding prizes or achievements can be derived from participation in the Aurora Roadtrip.

Article 27: Management

• The Aurora Roadtrip is managed and organized by Bijzondere Roadtrips BV.

Article 28: Applicable Law

• This agreement is governed exclusively by Dutch law.
